Third Annual Leadership Awards Honor Professionals from Atlanta, Keysville & Norcross

This honor recognizes an individual who has provided leadership that is worthy of statewide recognition including a commitment to quality, stewardship and integrity. Bryson, who at this conference was elected chair of the GHCA board of directors, is a recognized leader in long-term and postacute care. Through his work with UHS-Pruitt Corporation and the Georgia Health Care Association, Bryson contributes to the quality of life of those receiving long-term and post-acute health care in Georgia.

Lois Parrish, administrator of Keysville Nursing Home & Rehabilitation of Keysville, received the GHCA Leadership in Public Confidence Award. This honor recognizes an individual who has been a leader in developing the confidence of their local community and building relationships as well as trust.

William M. Small, president and CEO of The Fountain Companies, which owns The Fountainview Center for Alzheimer's Disease in Atlanta, received the GHCA Innovation in Leadership Award. Small was selected because of his development of the first long-term care community in the Southeastern United States developed exclusively for individuals with early, mid- and late-stage Alzheimer's disease.
